- Assessments are conducted by a team of RETAP professionals. The teams review facilities for opportunities for source reduction, reuse, recycling, and energy efficiency.*
- Written, confidential reports contain specific recommendations to save money, increase efficiency, reduce need for costly waste disposal and treatment, reduce liability, and promote a positive public image.
- There is no obligation to implement the recommendations; however, significant cost savings can be achieved. Companies assisted through RETAP have saved thousands of dollars.
