## MICHIGAN FARMERS & SMALL BUSINESSES RECEIVE USDA FUNDING FOR RENEWABLE ENERGY AND ENERGY EFFICIENCY PROJECTS

**East Lansing, Michigan September 8, 2008** – USDA Rural Development Director for Michigan Gene DeRossett today announced ten Michigan Farmers and Rural Small Businesses received \$317,612 in Renewable Energy Systems & Energy Efficiency Improvement grants and guaranteed loans for fiscal year 2008 under the USDA Rural Development Renewable Energy Program (Section 9006).

“USDA Rural Development is proud to take a leading role in improving rural energy efficiency,” said DeRossett. “These investments are also helping to revitalize Michigan’s economy through developing alternative energy resources.”
